99.9 THE HAWK "FLY SAFE WITH ABE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WODE ("Station"), owned and operated by Cumulus Radio Allentown, 2158 Avenue C., Suite 100, Bethlehem, Pa 17017, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **99.9 The Hawk "Fly Safe with Abe"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:
