99.9 THE HAWK'S "MORNING MINDBENDER" CONTEST OFFICIAL RULES

The Station will conduct the **99.9 The Hawk's "Morning Mindbender"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.  - 3. **How to Enter and Win.** Listen to the Station weekdays at approximately 6:45am ET during the Contest Period. When the Station airs the Morning Mindbender trivia question, listeners should call the Station at 610.720.9999. First caller to the Station with the correct answer to the trivia question, as determined by the Station in its sole discretion, will be eligible to win. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. - 4. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
