WODE "ALICE COOPER WEEKEND" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WODE ("Station"), 2158 Avenue C, Suite 100, Bethlehem, PA 18017, during available business hours Monday through Friday, Station website www.999thehawk.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **99.9 The Hawk** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station.
