WODE'S "CONTEST ROULETTE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WODE (the "Station"), 2158 Avenue C, Suite 100, Bethlehem PA 18017, during available business hours Monday through Friday, Station website <u>www.999thehawk.com</u>, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct **WODE's The Hawk Morning Show with Rick and Joel's "Contest Roulette"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - Contest Period. The Contest entry period will begin at approximately 5:45 am ET on Monday, June 26, 2023 and will run weekdays from 5:45am until 5:45am through Friday, June 30, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter and Win.** Listen to the Station during the Contest Period. At or around 5:45 am ET each weekday, when the Station airs the Mystery audio clip, listeners must call the Station at 610.904.9999. First caller (#1) to the Station with the correct response, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. **LIMIT ONE PRIZE PER PERSON.**
