WODE "DORNEY PARK WEEKEND" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WODE ("Station"), 2158 Avenue C, Suite 100, Bethlehem, PA 18017, during available business hours Monday through Friday, Station website www.catcountry96.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **99.9 The Hawk** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 11:55pm ET on October 15, 2023 to be eligible for the prize drawing. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Only one (1) entry per person per phone number will count as a submission for the duration of the contest period. Multiple texts will be accepted but will not increase your odds of winning. Multiple participants are not permitted to share the same telephone number. 7. Entry Conditions and Release.
