WODE'S "AFTERNOON TEXT TO WIN" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WODE (the "Station"), 2158 Avenue C, Suite 100, Bethlehem PA 18017, during available business hours Monday through Friday, Station website www.999thehawk.com.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct **WODE's Afternoon Text To Win**" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Between 4pm and 6pm, each weekday, when the Station announces keyword, listeners must text correct keyword to the Station at 610-904-9999 as determined by the Station in its sole discretion. Winner will be chosen at random for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest.
