#### WODE'S "RASPBERRY THEATRE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WODE (the "Station"), 2158 Avenue C, Suite 100, Bethlehem PA 18017, during available business hours Monday through Friday, Station website <u>www.999thehawk.com</u>, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct **WODE's The Hawk Morning Rave's "Raspberry Theatre"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. Eligibility. First caller (#1) to the Station with the correct response, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
